TERMS AND CONDITIONS

- 1) The Agency have to pay minimum wages with variable Dearness Allowances to the workers as fixed by the Government vide G.O.Ms.No.85, Labour, Employment, Training & Factories (Labour-II) Department, dt. 22.09.2007 including ESI and EPF.
- 2) The Organization shall undertake the general cleaning such as sweeping, wet cleaning of corridors, stair cases, cleaning of spider webs, clearing of lofts & sunshades, cleaning of toilets attached to the Chambers of Officers, General Toilets (Ladies & Gents), cleaning of stains near toilet corners & other places of the premises.
- 3) The Organisation shall use dis-infective materials such as bleaching scented phenyal, Napthalene balls, Acids, etc. in cleaning and shall pay attention to keep the premises dry and free from Mosquito menace wherever necessary.
- 4) The Organisation shall remove the waste material from the building premises.
- 5) The period of contract will be for one year from 01.05.2025 to 30.04.2026.
- 6) The Agency shall provide 1 labour for sweeping & moping and one scavenger on full time basis to clean the Toilets.
- 7) The Organisation has to entrust the work from 09.00 am to 05.00 pm subject to Labour Act.
- 8) The successful agency shall submit a Non-Judicial Stamp Paper worth Rs.100/- within 10 days from the date of receipt of the Order for execution of the agreement.
- 9) Cleaning of the general toilets (ladies & gents) using Phenyl and cleaning material, regularly (daily 2 times).
- 10) The Staff or Contractor shall also attend to any other work as entrusted by the Administrative Officer, Telangana State Legal Services Authority, from time to time.
- 11) The Member Secretary, Telangana State Legal Services Authority, reserves the right to terminate the contract at any time without assigning any reason.

- 12) The Member Secretary, Telangana State Legal Services Authority, may impose penalty of deducting certain percentage of amount from the bill, if any person absents to duty or of if no substitute is provided or if the work is found to be un-satisfactory or any damage is caused.
- 13) The Agency shall not sub-lease / entrust the work of maintenance to any other agency.
- 14) If the Agency intends to withdraw from the contract, it shall give at least One Month advance notice, as otherwise, the Member Secretary, Telangana State Legal Services Authority reserves the right to claim damages from Agency.
- 15) Initially, the contract shall be for a period of one year and may be extended further one year, subject to satisfactory performance, on the same terms and conditions.
